

The 83<sup>rd</sup> Annual Meeting of the Japan Sociological Society (JSS)

Call for Papers

November 6-7, 2010, Nagoya University, Japan

1. General Information

- (1) Applicants should e-mail all materials to the JSS executive office <jss@wwwsoc.nii.ac.jp> by June 21 sharp. If you can read Japanese, you can also submit them online at <http://www.gakkai.ne.jp/jss/>.
- (2) Applicants should be a member of JSS. If you are not a current member, you can apply for membership and then submit your paper.
- (3) Applicants should pay annual fees of JSS by August 10.
- (4) Applicants can present only ONE paper at a meeting. An exception is that you can present papers at a symposium and a session.
- (5) The program contains first authors only. Still, your abstract can include coauthors.
- (6) Additional materials can be distributed. Bring 50 copies or more.
- (7) You can use an LCD projector or a video player if they are equipped to your room. Bring a laptop computer.

2. Application for Regular Sessions

- (1) Submit Application Form for Regular Sessions, One-page Abstract, and Two-page Summary.
- (2) A paper is presented in 15 minutes and discussion follows. A regular session lasts for 2 hours with about 4 papers.
- (3) Related papers can be submitted. In such cases, submit the application form, abstract, and summary for each paper.
- (4) English can be used only at English sessions. Write an abstract and a summary in English. Otherwise, papers should be presented in Japanese.
- (5) Choose up to three sessions.

3. Application for Poster Session

- (1) Submit Application Form for Poster Session and One-page Abstract. Two-page Summary is NOT needed.
- (2) A poster session lasts for 2 hours.
- (3) English can be used. Write an abstract in English.
- (4) A poster is displayed in 90cm wide and 120cm high. Additional materials can be distributed.

4. Application for Travel Grant

- (1) Submit Application Form for Travel Grant, One-page Abstract, and Two-page Summary.
- (2) Also see Call for Papers for Travel Grant for more details.

(1) Application Form

- Download and fill out the form.

(2) One-page Abstract (see SAMPLE ABSTRACT below), (Microsoft Word file or PDF file, PDF file is recommended)

- Tables and figures can be included.
- (Layout) One-page A4 paper. 20mm margins. No page numbers. Text: about 35 lines in single column.
- Paper title (14 point font), subtitle (12 point font), both centered.
- Institution(s) and name(s) (11 point font) on the right. Text (11 point font) follows.
- Try to clearly describe aim/methods and results/conclusions.

(3) Two-page Summary (Microsoft Word file or PDF file, PDF file is recommended)

- Tables and figures can be used.
- (Layout) Both sides of A4 paper. 20mm margins. Text: single space in single column.
- Paper title (14 point font), subtitle (12 point font), institution(s) and name(s) (11 point font) on the top. Text (11 point font) follows.
- Summary should be distributed for 30 copies at a session.
